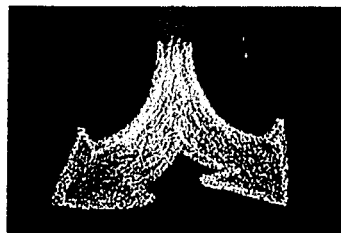

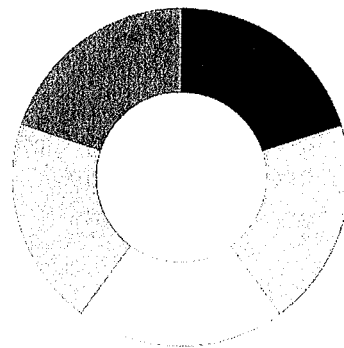

*Project Goals

Implementation of state-wide consistent use of the LOCUS.

1. Establish reliability standards within the state of Michigan thereby ensuring correct Level of Care placement regardless of region.
2. Establish validity verification process that ensures consistency of LOCUS scoring and Level of Care decision making across users.
3. Support the development of LOCUS monitoring and quality improvement approaches that recognizes the uniqueness of each organization and can be supported by all levels of administration.
4. Promote reliable clinical documentation that clearly demonstrates and supports dimension scores and level of care decisions.
5. Establish a plan for sustainable and reliable staff development that will support existing staff skills and ongoing organizational changes.
6. Build understanding of connecting person-centered planning and medical necessity with Level of Care decision-making when utilizing the LOCUS.
