## MDHHS Updates

### **Michigan Medicaid Recovery Incentives (RI) Pilot Presentation – Rita Subhedar**

Rita shared a PowerPoint of the Michigan Medicaid Recovery Incentives (RI) pilot with the committee.

- The department will be identifying PIHPs who are interested in participating in the pilot. The PIHPs will then work with their provider networks and identify the providers that will offer these services.
- In order to be eligible, you will need a diagnosis of stimulant use disorder (StimUD) or opioid use disorder (OUD). You can have multiple diagnoses but one of needs to be STIMUD or OUD.
- The department hopes to launch the 2-year pilot by October of 2024 and conclude it by 2026.

### **Opioid Advisory Commission Report – Michelle Boudreaux**

Michelle talked about the Opioid Advisory Commission report (link shared in agenda/in the meeting chat box/last bullet under this ). Michelle highlighted a few areas of interest.

- On page 7 & 8, this focused on complex needs, unmet needs, individuals struggling with substance use disorder (SUD) and mental health (MH) diagnoses which highlighted about 46% of individuals that are Medicaid enrollees and up to 69% of those were uninsured and did not receive treatment.
- On page 27, this goes into behavioral health spending and the percentages that were spent on COD needs.
  - Michelle found that interesting as the percentages seemed pretty low, so she is unsure how accurate it is or if it is reporting issues based on use of codes or use of information on what was spent.
  - Angie Butterwick-Smith commented the report focuses on integrated dual disorder treatment (IDDT) only and not on the other COD treatments that the department supports.

- She believes there are some reporting issues as well as a greater focus on those who have a severe serious mental illness (SMI) as opposed to the greater majority of the population that the SUD side serves of mild to moderate SMI were not really included in the report.
- She is hopeful the Opioid Advisory Commission in talking and interacting with people regarding the report will get an expanded knowledge base of the other services that are out there. They did request some behavioral health treatment episode data set (TEDS) from the department and maybe some Medicaid encounter data.
- This is their initial report, and it will be coming out annually.

- Co-occurring Intensive Prolonged Exposure Therapy (4-day training) on August 21-24, 2023.
